# Monthly Giving Program

## How does the program work?

When you use the Fund's automatic payment plan, your contribution provides even more scholarship assistance for students at the tribal colleges. The monthly commitment provides a predictable, regular source of income that allows us to more effectively plan and budget our program. The use of automatic deductions allows us to reduce administrative costs. The combination of reduced expenses and increased income means more students at the tribal colleges will receive scholarship support.

This special program also makes monthly pledge payments easy for you. And, your monthly commitment will go a long way towards helping more American Indians pursue a college education.

## How do I sign up for the Monthly Giving Program?

Just complete the form below. Select the payment option you prefer – direct debits from your bank account or monthly charges to your credit card – and indicate the amount of your monthly pledge to the American Indian College Fund. Please sign the form authorizing us to debit your account.

Then return the form in the enclosed envelope. If you have selected the direct debit option, please include a check for your first month's contribution. After that, your gift will be debited by the American Indian College Fund from your account, reliably and safely, on the 15th of each month. Your bank statement or credit card bill will show your monthly gift and act as a receipt for tax purposes. In addition, you will receive an annual acknowledgement including the total amount of gifts. ***If any of your account information changes, please notify the Fund as soon as possible.***

- **\$5/month** buys school supplies for a semester.
- **\$15/month** buys two average credit hours.
- **\$25/month** helps buy books for a semester.
- **\$65/month** provides an average scholarship.
- **\$167/month** provides annual tuition for one student.
